MACED works with people in Kentucky and Central Appalachia to improve the quality of life by creating economic opportunity, strengthening democracy and supporting the sustainable use of natural resources.

MACED's Enterprise Development program provides financial and technical assistance to develop entrepreneurs and strengthen small businesses and organizations. At fiscal year end, the combined portfolio of MACED and its affiliated nonprofit Appalachian Investment Corporation included 142 loans totaling \$8,341,183. We closed 50 loans totaling \$2,501,910. As a result, 96 jobs were saved and we project that another 59 new jobs were created.

We helped sustain and grow enterprises by combining our investment with training and technical assistance. Our staff and contractors provided 1,965 hours of one-on-one technical support. We also offered courses for emerging entrepreneurs and start-up businesses.

4b (Code: ) (Expenses \$ 385,527. including grants of \$ 202,248.) (Revenue \$ 42,000.)  
The Central Appalachian Network (CAN) is composed of seven nonprofits in Central Appalachia that promote environmentally sustainable community development by sharing learning and resources and by applying collaborative projects in key sustainable sectors. In 2009, CAN focused on growing sustainable agriculture value chains by inventorying existing needs, challenges, gaps, and opportunities for value chain expansion; identifying practitioners who are poised to contribute to this end; and convening practitioners and technical assistance providers to share expertise and facilitate new collaborations to grow value chains.

The Common Cents Financial Initiative is a pilot demonstration initiative that provides affordable and easily accessible emergency credit with an automatic savings component as an alternative to high-cost payday loan services. In FY09 we partnered with 11 enterprises covering over 1,000 employees and extended 343 loans. The Common Cents Financial Initiative was named winner of the 2008 Fifth Third Bank Innovative Nonprofit Award by the Nonprofit Leadership Initiative of the University of Kentucky. A video was created about the program as part of the award. It is available on our website and on YouTube.

MACED's research and policy efforts seek to remove the barriers that hinder sustainable development strategies and to make government a more effective partner in promoting development that works. In FY09 we released research reports and conducted media and policy advocacy to further our overall goals. We released a study on building a stronger support system for entrepreneurs and small businesses in Kentucky and provided testimony on the report's findings to the legislature's Interim Joint Committee on Economic Development. We helped form a new Kentucky Alliance for Sustainable Energy and authored op-ed articles on the Governor's energy and economic development plans. We also released studies on opportunities in the forestry and wood products industry in Appalachian Kentucky and approaches to Triple Bottom Line community development financing as part of a Ford Foundation process. Expenses for the program totaled \$269,039 and grants totaled \$100,000.

The Forest Opportunities Initiative helps landowners practice sustainable forest management, document new carbon sequestered in the forest and sell carbon credits through the Chicago Climate Exchange. In FY09 the pilot resulted in almost 10,000 acres of applicants, new management plans for 5,000 acres, and 3,000 acres of newly certified sustainable forests. We enrolled 27 landowners representing over 13,000 acres. Expenses for the program totaled \$195,282.
